Miss Preteen Virginia International Rules and Regulations

TO QUALIFY AS A CONTESTANT FOR MISS PRETEEN VIRGINIA INTERNATIONAL, YOU MUST MEET THE FOLLOWING REQUIREMENTS:

1. You must be at least 10 years of age and not older than 12 years of age as of the competition date to qualify in your age group.
2. Must be of good health and moral character.
3. You must live or go to school in Virginia or your parent/guardian must work in the State of Virginia.
4. Each contestant will be subject to a registration or contestant fee.
5. You agree that the judges' decision is final.
6. Any contestant or family member or guest showing less than sportsman like behavior will lead to the disqualification of the contestant.
7. If selected you agree to abide by all the rules and regulations of the state. If not, you will forfeit the title.
8. If contestant relinquishes, for any reason, her title, all cash prizes and/or other prizes must be returned in full, and in condition received.
9. You will permit TVM Productions and its licensees the right to use your photograph for publicity purposes in connection with the Virginia International Pageants.
10. You will permit TVM Productions and their licensees to televise live or by use of film or videotape any portion or all of the competition.
11. You will submit your photo for the photogenic competition (if applicable) when you arrive at the state competition registration.
12. Any misrepresentation of information on this application will result in disqualification.



Miss Pre-Teen Virginia International *Frequently Asked Questions*

What style of pageant is this?

We are promoting girls from across Virginia that are beautiful and natural. A light touch of makeup is allowed for onstage.

What are the eligibility requirements to compete?

Girls must be between 10 and 12 years of age; live in Virginia; go to school in Virginia; or a parent/guardian must work in Virginia.

Why do I have to give choices for a local sash?

Each pre-teen applicant will receive a local title. You do not compete in a local competition to receive this title. You may wear your local sash when doing community service, to assist you in obtaining sponsors, and when making appearances. You will be identified in the state program book and during the pageant by your local title. If your first choice isn't available, you will be given your 2nd or 3rd choice. Most contestants request the local title for the city, town or county in which the contestant lives. *Examples:* Miss Preteen Richmond International; Miss Preteen Alexandria International.

When do I receive my local sash?

Each Preteen contestant will receive her official local sash within 10 to 14 days of receipt of the full entry fee.

What are the categories of competition?

Each contestant will compete in onstage presentation, fun fashion, and evening gown. The evening gown segment may be a "flower girl" type dress or pageant dress. Fun Fashion is where each girl should have fun showing her personality and personal style. Each girl will have up to 1 minute to give an introduction to show her level of comfort speaking in public.

What is the entry fee?

The entry fee is \$175 per contestant. There is an optional photogenic competition which is an additional \$25 entry fee. Local sashes will be issued after full payment is received. Please make checks payable to: **TVM Productions.**

What are the prizes?

Each contestant will receive a trophy for her participation. The winner will receive a \$300 savings bond along with other great gifts and prizes. She will also be invited to make official appearances with Mrs. Virginia International and Miss Virginia International during her reign.

What is the deadline for entry?

All entries must be turned in by September 10, 2010.
